

The Farm Dog Certified Test consists of 12 situations that a dog might encounter in a typical farm environment.

All of the exercises are done on leash.

Test 1: Greet the judge

The handler approaches the judge with the dog at their side on a loose lead. The dog must not jump, or show aggression or excessive shyness.

Test 2: Walk around the farm and a passive stranger The handler walks the dog on a loose lead at least 200 feet around a variety of objects and near a sitting person.

Test 3: Jump on hay/straw bale

Handler instructs the dog to jump on a bale and stay until released by the judge.

Test 4: Walk past farm animals Handler walks the dog on a loose lead in view of penned farm animals.

Test 5: Walk over or through unusual surfaces The handler walks the dog over three unusual surfaces, such as a plastic tarp, a sheet of plywood, and metal grating lying flat on the ground.

Test 6: Supervised separation The handler places the dog in a crate and walks out of sight for a minimum of 1 minute.

Test 7: Pass through a gate

The dog stays while the handler opens the gate, passes through on the handler's command, and stays while the handler closes the gate.

Test 8: Handler feeds livestock The dog is tethered while the handler approaches and feeds livestock in an enclosure.

Test 9: Reaction to another dog

The dog remains stationary on a loose lead while another dog is walked by twice, about 10 feet away.

Test 10: Reaction to noise distraction The dog is exposed to two common farm sounds (such as hammering nails, leaf blowers, tractor engine, etc.) and must not panic.

Test 11: Dog approaches livestock The handler approaches penned livestock with the dog on a loose lead. The dog may not lunge or be fearful or aggressive to the stock.

Test 12: Physical examination

The handler examines the dog for plant material or debris collected while working on the farm—examining the ears, eyes, mouth, coat, and toes.

Test items 2-11 may be conducted in a different order than listed.

ELIGIBLE BREEDS & REGISTRY

Open to all dogs at least 9 months of age that are individually registered with the AKC, recorded in the FSS program, dogs with PAL numbers or dogs enrolled in the AKC Canine Partners program. Females in season may not show.. A dog may enter only once per event. (An event is defined by an event number.) Dogs requiring registry in Canine Partners must be spayed or neutered and are subject to a separate registration fee of \$35.00 to the AKC.

RIBBONS & PRIZES

Qualifiers will receive a dark green flat ribbon for successful pass of test.

A "New Title" rosette will be available for any dog finishing a title. While they last.

GENERAL RULES

- All entries must be nine (9) months of age or older on the day of the test.
- Dogs MUST be tested with a flat collar, *no tags hanging, no slip collars.*
- NO FLEXI LEADS, PINCH/PRONG COLLARS OR ELECTRONIC COLLAR! ARE ALLOWED ON THE TEST GROUNDS!**
- The test committee reserves the right to bar known aggressive dogs from the event site.
- The following actions may result in a fine and/or being excused from the event: exhibiting unsportsmanlike conduct, not picking up after one's dog, or littering in any area of the event.
- NO ONE is allowed in the test area without the express permission of the Test Chairman, except the Judge and appointed Committee.
- There is **NO SMOKING** anywhere near the FDC testing location! A designated smoking area will be available. Please be respectful of others.
- There will be a \$20 charge for anyone not picking up after their dogs or themselves.
- There will be a **\$25 service charge** for all returned checks.
- No refunds given. A veterinary certificate is needed for lame dogs or bitches in season to receive a refund.

Directions to Kinley Training Facility

❖ **From Chardon:** Take Rt. 6 East from the square 3.6 miles then continue straight ont Rt. 166 East (Rt. 6 makes a sharp turn to the right where it intersects Rt 166). Travel 1.0 miles NE on RT 166 then turn Left (North) onto Williams. After approximately 1.6 miles Williams crosses Radcliff Rd. and becomes Proctor Rd. Kinley Training Center is approximately 0.2 miles North of Radcliffe Rd. on the left.

❖ **From Painesville:** Take Rt. 86 SE toward Leroy Twp. Continue approximately 3.1 miles past Five Points (Vrooman Rd. intersection) to Proctor. Turn Right onto Proctor (South) and travel 1 mile to Kinley Training Center.

❖ **From Cleveland and Points West:** Take I-90 E to Exit 205, Vrooman Rd. Go Right (South) and travel 1.4 miles to Rt 86. Turn Left onto Rt. 86, then travel 3.1 miles to Proctor. Turn Right onto Proctor Rd. Kinley Training Center is 1 mile down on the right.

❖ **From Ashtabula and PA:** Take I -90 W to Exit 205. Turn Left on Vrooman Rd. Go Left (South) and travel 1.4 miles to Rt 86. Turn Left onto Rt. 86, then travel 3.1 miles to Proctor. Turn Right onto Proctor Rd. Kinley Training Center is 1 mile down on the right.
